INFORMATION REGARDING THE FILING OF A FICTITIOUS BUSINESS NAME STATEMENT

- Be certain the information in the statement is correct and complete before filing it. You cannot make changes to the statement once it has been filed. Any changes would require the Abandonment & publications and then filing of a new statement, payment of the filing fees again, and publication in a newspaper in San Benito County.
- When you file a fictitious business name statement, it does not reserve the name for your exclusive use. The filing is for consumer protection, and is a requirement under Business & Professions Code Section 17900 and 17913.
- The County Clerk's Office cannot refuse to file a fictitious business name statement because the name is already being used by someone else.
- If there is a conflict between business owners using the same or similar names, it becomes a legal matter between the business owners.
- Residence address (where you live) must be listed under the registrant information. If the registrant is a corporation/LLC, an address (not PO Box) and the State of Incorporation/Organization must be listed.
- ALL information contained in the statement is a **PUBLIC** record, including your residence address. Anyone can purchase copies of the statement.
- All original filings as well as new filings with a change in the facts from the previous filing must be published. The statement must be published in an adjudicated newspaper, once per week for four consecutive weeks. The first publication must begin within thirty days of the date the statement was filed in the County Clerk's Office. See attached information on Page 4 of this application.

Our print deadline for FBN'S is every Monday at 10 a.m. for the edition of the paper that appears in print the following Friday. This means the Monday before the 30 days is up, before 10 a.m., is the very last moment we can receive FBN'S in our office, and run it in an edition of the paper that meets the filing's deadline. We recommend that the statements are submitted WELL BEFORE that date to ensure that we can publish them within their filing deadline.

Fictitious Business Name Statements can be sent to the newspaper by mail, email or in person. We will continue to run FBN'S from our Hollister office, but submissions by mail or email are preferred.

Business and Professions Code Sections

Business and Professions Code Sections 17917 & 17924:

Within 30 days after a fictitious business name statement has been filed, the registrant shall cause a statement in the form prescribed to be published in a newspaper or general circulation in the county in which the principal place of business of the registrant is located or, if there is no such newspaper in that county, then in a newspaper of general circulation in an adjoining county. If the registrant does not have a place of business in this state, the notice shall be published in a newspaper once a week for four successive weeks and an affidavit of publication filed with the county clerk when publication has been accomplished. An affidavit showing the publication of the statement shall be filed with the county clerk within 30 days after the completion of the publication.

If a re-filing is required because the prior statement has expired, the re-filing need not be published unless there has been a change in the information required in the expired statement, provided the re-filing is filed within 40 days of the date the statement expired.

Business and Professions Code Section 17930:

Any person who executes, files, or publishes any fictitious business name statement knowing that such statement is false, in whole or in part, shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine not to exceed one thousand dollars (\$1,000).

Tax Collector
