This is in response to your email received December 6, 2016, in which you requested a postponement of the hearing scheduled in Sacramento for January 24, 2017. Pursuant to Regulation 5522.8, subdivision (b)(1)(A), of the Board's Rules for Tax Appeals, the request has been granted. The hearing has been rescheduled to the **Tuesday, April 25, 2017**, Board meeting in Culver City. However, there might be a chance this matter will be rescheduled to April 26 or 27, 2016, so please plan accordingly. A new Board Hearing Notice will be mailed approximately 90 days before the date of the hearing.

As provided in Regulation 1807, subdivision (d)(4), the briefing will be conducted in accordance with Regulations 5270 and 5271 of the Board's Rules for Tax Appeals. The new briefing schedule will be as follows. The City of Ontario may file an opening brief with the Chief, Board Proceedings Division no later than March 1, 2017. If the City Ontario does so, we will mail the other parties a copy of that brief, who may then file a reply brief with the Chief, Board Proceedings Division no later than March 21, 2017.

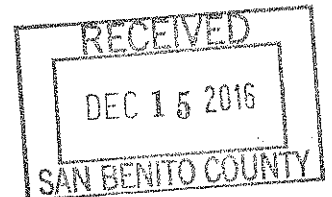
