Pursuant to the California Environmental Quality Act (CEQA), the Guidelines of the Secretary for Resources and the San Juan Bautista requirements, this Notice of Exemption is transmitted to you for filing. Project Description:

The property owner is requesting a parcel map approval for a four parcel minor subdivision with a remainder parcel resulting from the existing 12.5 acre parcel. The proposed minor subdivision will extend from Old San Juan-Hollister Road southeasterly to front with Mission Vineyard Road. The current zoning classification and General Plan Designation is Industrial.

The proposed project will create four standard lots and a remainder parcel. The remainder parcel will be for public facility purposes whereas the four parcels will belong

to the property owner, The property owner currently intends to continue to farm the land, but would like to record a parcel map as attached. There are no plans to develop the parcels beyond farming at the present time.

Determination:

On June 12, 2018, following a duly-noticed public hearing, the City of San Juan Bautista Planning Commission voted to approve the Parcel Map/Minor Subdivision by resolution. No appeals have been filed. A copy of the document(s) may be examined at 311 2nd Street, San Juan Bautista, CA 95045 in file no. PM 2018-101.

1. An Exemption from Environmental Review has been prepared pursuant to the provisions of CEQA under Sections 15300.2, 15301, & 15315 (Exceptions, Existing Facilities, and Minor Land Divisions respectively)
2. This project in its approved form has been determined to be exempt from further environmental review because the project fits within existing facilities to be used for public utilities, exceptions because significant effects on the environment because no development or land use changes are proposed for this project and this is a minor land division on industrial zoned land, has a less than 20% slope and has not been annexed or divided in any way in the last two years.
